REQUIREMENTS AND ADMISSION PROCESS FOR EXPERT MEMBERSHIP

Eligibility Requirements

Professional Qualifications

- Advanced degree (Master's or Ph.D.) in relevant field, or equivalent professional experience
- Minimum of 8 years of documented professional experience in the area of expertise
- Current active involvement in the field of specialization
- Demonstrated track record of contributions to their field
- Verifiable professional references

Professional Achievement Indicators (desirable)

- Published work in peer-reviewed journals or respected industry publications
- Speaking engagements at conferences or industry events
- Patents or innovative contributions to their field
- Leadership roles in professional organizations
- Awards or recognition in their area of expertise
- Successful implementation of significant projects

Language Requirements

- Professional proficiency in English and working knowledge of Spanish
- Additional languages desirable
- Ability to communicate effectively in international settings

Ethical Standards

- Clean professional record
- No conflicts of interest that could compromise objectivity
- Commitment to ethical practice in their field
- Willingness to adhere to organization's code of conduct
- Declaration of any potential conflicts of interest

Application Process

Step 1: Initial Application

- Complete online application form
- Submit detailed professional CV/resume
- Provide professional biography
- List key achievements and contributions to field
- Include links to published works or portfolio

Step 2: Documentation

Submit verified copies of:

- Academic credentials
- Professional certifications
- Relevant licenses
- Professional association memberships
- Awards and recognition documents

Step 3: References and Verification

- Provide three professional references
- Submit letter of recommendation from current/former employer or academic institution
- Authorization for background verification
- Proof of current professional status

Step 4: Expert Review

- Application review by relevant field committee
- Assessment of qualifications and experience
- Evaluation of potential contribution to organization
- Review of submitted materials and references

Step 5: Interview Process

- Initial video interview with field committee
- Discussion of potential contributions and involvement
- Presentation of expertise and experience
- Q&A about specific areas of knowledge

Step 6: Final Evaluation

- Committee deliberation and voting
- Assessment of interview performance
- Review of complete application package
- Final decision on membership

Membership Categories

Full Expert Member

- Meets all qualification requirements
- Can lead projects and initiatives
- Access to all resources and benefits

Associate Expert Member

- Meets most requirements but may lack some experience
- Can participate in projects

- Access to basic resources and benefits

Emeritus Expert

- Senior experts with distinguished careers
- Advisory role in organization
- Access to full membership and Board of Directors
- Special status in mentoring programs
- Full access to resources and benefits
- Entry fee only, after the first year, charges are waived

Renewal and Maintenance

Annual Requirements

- Active participation in organization activities
- Contribution to at least one project or initiative
- Attendance at minimum number of events/meetings
- Compliance with continuing education requirements
- As any membership-based organization some fees are required:
- Entry fee of 100 USD.-
- After the first year 5 USD.- per month or 50 USD annual payment

Periodic Review

- Review of membership status every 3 years
- Assessment of ongoing contributions
- Evaluation of participation level
- Update of professional achievements

Application Timeline

- Initial application review: 2-3 weeks
- Documentation verification: 2-4 weeks
- Reference checks: 2-3 weeks
- Expert committee review: 3-4 weeks
- Interview process: 1-2 weeks
- Final decision: 1-2 weeks
- Total estimated time: 11-18 weeks

Appeals Process

- Written appeal within 30 days of decision
- Review by separate appeals committee
- Additional documentation may be requested
- Final decision within 45 days of appeal
- No charges will be made before application is accepted.
